# **Agenda Item #8 Unfinished Business**

- a. SHPO grants:
  - i. Historic Preservation plan:

Rob shared that the full draft report will be available next week as soon as survey and interview information is synthesized. Almost 80 people responded to the survey. Unfortunately, due to cancellations and non-response, only 6 interviews of the 12 will be completed. Interviewees included Michelle O'Brien, Alma Parker, Peter Stanton, Karen Pitcher, Dave Kiffer and Richard Jackson. Deborah recommended Nathan Jackson and Delores Churchill as additional interviewees and asked if TNSDS had included the Waterfront Promenade plans. Steven Reeve promised to send a copy to TNSDS staff. Anita noted that the work must be completed by August 31.

# ii. Colorful Characters signage:

Anita confirmed that SHPO was willing to grant a 30 day extension given that the sign production company is behind schedule due to staff and material shortages. Interested commissioners will be

meeting August 5 at 10 am at the Museum to review signs. Stephen hopes that Historic Ketchikan can mobilize private funds for additional signs.

# b. Aleut Memorial Project Update

Amanda shared that John Radizilowski had compiled names of the deceased Aleuts. Anita noted that his recommendation was to contact the Pribolof Islanders Association next to determine families' interest in the project. Irene mentioned that there is a lot of interest in this project including from KIC, KAAHC, and the Forest Service. She also noted that Chad Frey (Schoenbar Social Studies teacher) is leading a class project as well. Anita said that Judith McQuerry is very interested in moving the project forward this fall. (Judith first brought the idea to the Commission) Kris shared that Jennifer Hanlon would be the USFS contact as she's the Tribal Relations Specialist.
